And whereas, provision of Section 43 (4) of the Act *ibid* has been invoked and matter was taken up with the Government of Haryana, Town & Country Planning Department to authorize the Haryana Real Estate Appellate Tribunal Karnal to hear appeals made against the directions or decisions or orders of the Himachal Pradesh Real Estate Regulatory Authority, Shimla and the Adjudicating Officer. Whereas the Haryana State Government *vide* its notification No. 1/92/2017-ITCP dated 29th September, 2020 has been pleased to confer jurisdiction upon the Haryana Real

Estate Appellate Tribunal located at Karnal, to hear appeals preferred against the directions or decisions or orders of the Real Estate Regulatory Authority, Himachal Pradesh.

Now, therefore, in exercise of the powers vested by the Section 43 (4) of the Real Estate (Regulation and Development) Act, 2016, the Governor of Himachal Pradesh is please to confer the power and jurisdiction upon Haryana Real Estate Appellate Tribunal at Karnal, to hear appeals preferred against the decisions or orders of Real Estate Regulatory Authority, Himachal Pradesh and the Adjudicating Officer, under the *ibid* Act of 2016.
